

III. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

2. ENTRY RIGHT TO SHOWGROUNDS/ACCREDITED PERSONS

Entry right to the stable area according to FEI Veterinary Regulations Articles 1008-1009.

NUMBER OF ACCREDITED PERSONS:

Athlete: each athlete of a horse that starts will be issued with three vehicle passes, one lorry/parking permit, also three security wristlets for access to the stable compound. No trainers passes will be issued and athletes are responsible for allocating one of their vehicle passes to their trainer if they wish. **For security reasons, the registration number of all horseboxes and an emergency contact number for the person responsible on the showground, will be required in advance for the preparation of the permit. This permit will be issued on arrival at the Event and MUST be displayed on the windscreen of the horsebox at all times.** Checks will be made.

Groom: one grooms badge/identity wristlet per horse will be issued.

ARMBANDS: On arrival at Burghley each athlete will be issued with 3 armbands, to be worn while walking the cross country course. Anyone without an armband must walk outside the string.

Horse Owner: one vehicle pass and two security wristlets will be issued to the owners of horses that start, as recorded in the horse's FEI Passport (up to a maximum of 3 owners per horse).

Family/Extra Grooms, etc: application for additional security wristlets for access to the stable compound must be made at time of entry and each application will be considered on its merits (a maximum of two per horse will be issued). Separate passes will be available for family members who require access to the stables area but NOT the stable compound. These passes are for internal use between the show area and stable fields and will not gain entry to the showground from any external gate.

Visitors & Officials: All Officials and Officers of National Federations must apply for admission tickets no later than 16 August 2019. Thereafter, whilst welcome, they will be required to pay at the gate.

Team Officials: One Chef d'Equipe and Veterinarian per NF will be accredited with full access to the stables. They/their NF will be responsible for their own accommodation.

Access to Stables

Strict stable security will be in force. Any owner, trainer, veterinarian or other person not in receipt of an official security wristlet must apply in person to the Event Organisers' office for a temporary admission pass, the issue of which is at the discretion of the OC. Access to stables will be limited to the persons indicated in Vet. Regs. Art 1009.

No horse will be permitted to enter the Stables prior to 09.30 hours on Tuesday, 3 September, except with specific prior arrangement.

All horses entered in the Event must arrive **no later than 12.00 hours on Wednesday, 4 September**, to permit the First Examination to take place prior to the First Inspection.

Thereafter no horse may leave the competition site before the end of the Event, unless it is eliminated, withdrawn or otherwise retired from the competition.

The horses' passport will be retained until the end of the competition when athletes are responsible for demanding its return.

Caravan Parking: each competitor will be allowed one site to park a caravan in stables caravan park (no caravans can be parked with the horseboxes). For security reasons, an emergency contact number for the person responsible for the caravan will be required in advance for the preparation of a permit. This permit will be issued on arrival at the Event and **MUST** be displayed on the window of the caravan at all times. Checks will be made.

4. QUALIFICATION

Entries have to be in accordance with Art. 520 and 521 of the FEI Eventing Rules, 25th edition, effective 1 January 2019.

The eligibility to compete will be determined by a combination of the following:

- The level of the Athlete category (National, D, C, B, A) (Art.519)
- The achievement of a number of Minimum Eligibility Requirements according to the eligibility matrix of requirements (Art. 520)

Minimum Eligibility Requirement (MER)

A Minimum Eligibility Requirement is achieved by completing a Competition within minimum parameters of all round performance as follows:

- a. Dressage Test: not more than 45 penalty points or 55%.
- b. Cross Country Test:
 - a clear round (activating a maximum of one frangible device will maintain the MER result on cross country)
 - not more than 75 seconds exceeding the optimum time in the Cross Country Test for one, two and three and four star level Competitions and 100 seconds in the case of five star level Competitions.
- c. Jumping Test: not more than 16 penalties at obstacles.

Note: all MERs obtained in the previous years will be counted according to the rules in place at that time

Minimum Eligibility Requirement Validity period CIs and CIOs

The valid period for obtaining a Minimum Eligibility Requirement for is anytime until:

- At least 24 days before the Cross Country Test of the competition for which is needed if the MER has been achieved at a long format competition (CCIs-L).
- At least 10 days before the Cross Country Test of the competition for which is needed if it has been achieved at a short format competition (CICs-S).

Athletes Categories

FEI Athlete categories for Eventing define a recognition of proven competence of the Athlete at a certain level.

W-CH and OG to count as 5star level MER towards Athlete categorisation

Athletes will be categorised (uncategorised International, D, C, B, A) according to their performance in a rolling eight year period as defined in the following table.

D	Fifteen (15) MER at FEI CCI short (CCIs-S) or long (CCIs-L) format Competitions of two star level or above; or five (5) MERs at FEI CCI short (CCIs-S) or long (CCIs-L) format competitions at higher level.
C	Fifteen (15) MER at FEI CCI short (CCIs-S) or long (CCIs-L) format Competitions of three star level or above; or five (5) MERs at FEI CCI short (CCIs-S) or long (CCIs-L) format competitions at higher level.
B	Fifteen (15) MER at FEI CCI short (CCIs-S) or long (CCIs-L) format Competitions of four star level or above; or five (5) MERs at FEI long format (CCIs-L) competitions at five star level.
A	Fifteen (15) MER at FEI CCI short (CCIs-S) or long (CCIs-L) format Competitions of four star level or above of which five at five star level.

The Athlete category will be updated according to the performances on 1st of July and at the end of each calendar year taking into account the rolling eight years.

The following table details the requirements needed to be entered in the different formats, categories and levels of international Competitions. NFs are required to set national participation requirements as per Art 516 to apply for all categorisations.

Exceptions for MERs:

- a) The 1st activation of a frangible/deformable device (11 penalties) will still allow a MER.
- b) When multiple Minimum Eligibility Requirements are required (for CIs and CIOs), one of the Minimum Eligibility Requirements can be achieved incurring 20 penalties at the obstacles of the Cross Country Test.

NOTE: NFs have the option to apply to use CNs (National Competitions) for qualification purposes only to replace events cancelled due weather conditions and/or exceptional circumstances.

A **jeroboam of Pol Roger Champagne** will be presented to the winning athlete and a magnum to the athletes placed second and third.

Sport Horse Breeding of Great Britain will present a bronze and rosette to the owner of the highest placed horse sired by an SHB (GB) Graded Stallion or HIS Premium Stallion, provided it finishes in the first twelve places.

Twemlows Stud Farm will award a scholarship for two embryos to the highest placed British domiciled mare completing the competition providing it is placed in the top 20.

The Worshipful Company of Farriers will award a rosette and a plaque to the owner of the "best shod horse", and a plaque to the registered farrier responsible for its feet and shoeing. Judging will take place during the First Horse Inspection on Wednesday, 4 September.

£500 expenses will be paid to every owner whose horse completes the competition without winning a prize and £50 will be awarded to the groom in charge of each horse that starts the Cross Country Test.

Peden Bloodstock International Pairs Challenge Offers a total of £4,000 prize money. (see page 31 for details)

Rolex Grand Slam of eventing: a cash prize of \$350,000 will be awarded to the athlete who wins Burghley CCI5*-L, Badminton CCI5*-L and Kentucky CCI5*-L (USA). Such wins may cover more than one calendar year and may begin with any of the three competitions but must occur consecutively.

All cups and trophies are presented on an annual basis and must be returned for presentation the following year.

IMPORTANT

No horse will be permitted to enter the Stables prior to 09:30 on Tuesday, 3 September, except with specific prior arrangement.

Peden Bloodstock will advise on and co-ordinate all import and re-export formalities if contacted a minimum of 10 days in advance of arrival.

With the impending Brexit decision, we are not yet in a position to advise on the import and re-export health or customs requirements which will be in force at that time. However, Peden Bloodstock will communicate all relevant information to all registered interested parties once legislation has been agreed.

2. HEALTH REQUIREMENTS

GENERAL

In accordance with the FEI Code of Conduct for the Welfare of the Horse it is imperative that all Horses at FEI Events are physically fit and free from infectious disease before being allowed to compete.

5. INJURY SURVEILLANCE

FEI Veterinary Regulations, Chapter VIII:

Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

6. TRANSPORT OF HORSES

Horses must be fit to travel and be transported in suitable vehicles for the transport of horses. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

7. VENUE ARRIVAL INFORMATION & FITNESS TO COMPETE

7.1. PASSPORTS. FEI General Regulations Article 137

For all issues relating to FEI Horse Passports/FEI Recognition Cards please contact your National Federation.

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses entered in CIMs and in CSIP in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations** and may not be allowed to compete.

NB for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

7.2. VACCINATIONS - EQUINE INFLUENZA. FEI Veterinary Regulations Article 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory.

7.3. EXAMINATION ON ARRIVAL. FEI Veterinary Regulations Article 1031

On arrival at an Event venue, all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

7.4. HORSE INSPECTIONS. FEI Veterinary Regulations Articles 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

7.5. LIMB SENSITIVITY EXAMINATION. FEI Veterinary Regulations Articles 1048-1053

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event, including, but not limited to, between rounds and before the Jump Off. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP). FEI VETERINARY REGULATIONS, CHAPTER VII

8.1. SAMPLING. FEI VETERINARY REGULATIONS CHAPTER VII

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with the Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

8.2. ELECTIVE TESTING. FEI VETERINARY REGULATIONS ARTICLES 1057 AND 1058

Elective Testing may be carried out prior to an Event to check for the presence of prohibited substances. Please refer to <https://inside.fei.org/fei/cleansport/horses> for information and details.

XIII. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEI's Anti-doping Rules for Human Athletes (ADRHA).

XIV. ADDITIONAL INFORMATION

1. MEDICAL INFORMATION FORM FOR ARMBANDS

Declaration of medical condition

Athletes with medical conditions that may be relevant in the case of a medical emergency are responsible, at every Event when riding, for wearing a medical data carrier* from a system provider able to communicate information at least in English. Alternatively (and at the minimum) a medical armband of good quality can be used. Athletes who chose to wear an armband should download and fill the form available for this purpose on the FEI's website <http://inside.fei.org/fei/your-role/officials/eventing/forms>.

** Medical data carrier (also called "medical identification tag"): small emblem or tag worn on a bracelet, neck chain, or on the clothing, intended to alert paramedics/physicians/ first responders that the wearer has an important medical condition.*

Conditions that are relevant include recent head injury, serious past injuries/surgery, chronic health problems such as diabetes, long-term medications and allergies. If in doubt, the athlete should discuss this with his own treating physician."

2. INSURANCES AND NATIONAL REQUIREMENTS

Equestrian sports involve inherent dangerous risks. To the greatest extent permitted by law, the FEI and the FEI Event Organiser shall NOT be liable for any damages relating to loss of property or injury of any kind to Athletes, Owners, Support Personnel or Horses at or in connection with an FEI Event and the FEI expressly excludes all such liability.

2.1. ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1. Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses, which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2. Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.1.3. Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage, which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place, which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.2. ATHLETES AND OWNERS

2.2.1. Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2. Additional Liability Information

2.2.3. Horse Insurance

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

3. PROTESTS/APPEALS

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF 150.- or equivalent.

4. DISPUTES

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

5. MODIFICATION TO SCHEDULE

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate.

6. ADDITIONAL INFORMATION FROM THE ORGANISER

- 6.1 **DISCLAIMER OF LIABILITY:** Save for the death or personal injury caused by the negligence of the Organisers or anyone for whom they are in law responsible, neither the Organisers, Burghley Horse Trials Limited, British Equestrian Federation, British Eventing Limited, the Trustees of Burghley Estate, nor any agent, employee or representative of these bodies accepts any liability for any accident, loss, damage, injury or illness to horses, owners, riders, grooms, exhibitors, spectators, dogs, land, cars, their contents and accessories or any other person or property whatsoever, whether caused by their negligence, breach of contract or in any other way whatsoever. Further, the Organisers reserve the right to refuse admission to Burghley Park to any person or to withdraw permission at any time to remain in the Park, and they shall not be required to give any reason for such action.

The Organisers shall not be liable in respect of any loss or damage whatsoever arising from the abandonment, cancellation or postponement of Land Rover Burghley Horse Trials, or any such eventuality.

- 6.2 Burghley Horse Trials is committed to protecting your personal data and processing it only in accordance with legal requirements. For more details you should request a copy of our Privacy Policy.

We process your personal data as it is necessary for the performance of our contract with you to facilitate your entry to the Event.

We retain your data in accordance with our retention schedule to simplify future applications. You have various rights in the data we hold including rectification and objecting to processing.

- 6.3 **PHOTOGRAPHIC RIGHTS:** Athletes participating in an Event agree to be filmed, televised, photographed, identified, interviewed and otherwise recorded during the Event for the purposes of media coverage of the Event (by means of all and any media throughout the world in perpetuity) and the promotion of the Event and the sport. Athletes therefore assign with the full title guarantee in perpetuity to the FEI all rights of any nature in any such recordings. Athletes agree that their name and image and any photograph and moving images taken of them at an Event may be used by the FEI and/or OC for the purposes of publicising the Event and promoting the sport.

6.4 HAT CAMS

Hatcams are only permitted under the following conditions:

- a) The actual hatcam to be used must be shown to the Technical Delegate and, in his absolute discretion, approved by him.
- b) It should be noted that Burghley Horse Trials is the owner of the global broadcast rights for the Land Rover Burghley Horse Trials, including for broadcast on TV, Radio, Mobile and Internet platforms.
- c) All hatcam footage must be made available on request to the Organising Committee for use in its official broadcasts / streaming / social media.
- d) Other than through the organisers' official channels, no hatcam or other footage of actual competition may be broadcast, streamed or posted on social media until after the competition has finished on Sunday afternoon.

6.4 PEDEN BLOODSTOCK INTERNATIONAL PAIRS CHALLENGE

An additional competition will be held within the CCI4*. After the First Horse Inspection, the top fifteen highest ranked 'British' athletes competing at Burghley, will be paired with the top fifteen 'rest of the world' athletes competing at Burghley as follows, the no 1 ranked British athlete will be paired with the no 15 'rest of the world' athlete, the no 2 ranked British athlete will be paired with the no 15 'rest of the world' athlete etc. Rankings will be taken from the FEI published table as of the 30 August 2019. The pairs' competition scores will be added together and placing calculated as under the FEI Rules for Scoring. Prize money will be awarded to the top three placed pairs as follows:

1st Prize: £2,500 (£1250 each)
2nd Prize: £1000 (£500 each)
3rd Prize: £500 (£250 each)

8. PRIZEMONEY DISTRIBUTION

IMPORTANT

The total amount of prize money shown for each Competition in the schedule must be distributed. (FEI General Regulations articles 127 and 128)

The value of the 1st prize must not exceed 1/3 of the total prize money distributed for the competition. The minimum number of prizes offered for each competition must be allocated on the basis of one prize for every commenced four Athletes, with a minimum of five prizes.

DEDUCTIONS FROM PRIZE MONEY AT COMPETITIONS:

Full details of any deductions from prize money must be outlined in the schedule. This includes government taxes. If it is necessary for Organisers to deduct such taxes, they **must** provide participants with an official form indicating the amount of tax deducted.

The tax form must be provided to the athletes upon arrival and returned to the Organiser prior to departing.

All results must include FEI Passport Registration number of horses and FEI ID number of Riders.

Please note that as per Art. 109.6 (GR): OCs of International Events must inform the FEI and NFs whose teams or individuals have taken part, of the results and prize money paid to each placed Athlete and team, within five (5) days following the Event, unless otherwise specified for qualification and ranking reasons as communicated by the FEI. Failure from OCs of International Events to provide the FEI with the appropriate result(s) and/or prize money information by the aforesaid deadline and/or in the aforesaid format shall entail a warning for the first violation and thereafter a fine of CHF 1'000.- per violation.

3. STEWARDING (Only for Jumping test of the Eventing competition, as per FEI Jumping rules)

- If an athlete is uncertain as to whether the boots he/she intends to use during an event are allowed, he/she or his/her representative should show the boots to the Chief Steward for his/her opinion before the boots are used in training or in competition.
- In addition, athletes are to be made aware that hind boots must be removed and placed again on the horse's legs in the presence of a Steward while in the warm-up arena prior to entering the competition arena for certain competitions. (If bandages are used in place of boots, athletes are not required to remove the bandages in the warm-up arena.) This procedure is compulsory for competitions for which boot and bandage control is mandatory, that is the Nations Cup, Championships, and the competition with the highest prize money, and is at the discretion of the Chief Steward for other competitions.
- As an alternative to carrying out this procedure at the time designated by the Steward an athlete may ask his/her groom to take the boots to the in-gate and place them on the horse's legs in front of the Steward prior to the combination entering the arena.
- The Steward has the authority to intervene if a boot is deemed excessively tight by instructing that the boot be removed and put on again correctly. *[Stewards are to note that it is normal for a horse's gait to be somewhat affected immediately after boots have been removed and re-placed.]* If an athlete or his/her groom refuses to remove and re-place the boot(s) when instructed to do so by the Steward, a Yellow Warning Card will be issued to the athlete in question.
- If it is deemed impossible or unsafe to remove the hind boots in the warm-up arena prior to the combination entering the competition arena, due to an extremely excited or nervous horse, the boots of the horse in question are to be removed by the athlete/groom following the athlete's round upon leaving the arena and inspected by the Steward. This inspection may be carried out during the boot and bandage control if the boot and bandage control is carried out for the competition in question.
- This procedure does not replace boot and bandage control after completion of an athlete's round for competitions for which boot and bandage control is mandatory (refer to JRs Art. 244.1)
